D.P.A.O. End Of An Era



Twenty-two years ago, my journey began with the Disabled Persons Action Organization of Jefferson and Lewis County. I photographed the Rock & Roll Hall Fame Inductees, the Doobie Brothers at the Watertown Fairgrounds Arena. It was the beginning of an amazing run of photographing over a hundred and fifty musical acts, comedians and entertainers. My heartfelt thanks go out to Joe Rich. He gave me the opportunity to not only capture the live performances, but to photograph behind the scenes, including many of the Meet and Greets attended by the concert attendees and the performing celebrities. Looking back on that time, I was just beginning to grasp what it meant to be a photographer. I volunteered my time, and I am so glad I did. The opportunity to be the house photographer, along with a constant learning process, allowed me to become a professional.

Unfortunately, Disabled Person Action Organization announced in October they would be discontinuing their Summer Concert Series for the foreseeable future.

For the past fifty one year's D.P.A.O. has provided over 250 concerts, promoting top notch entertainment to the North Country. Rock acts Journey. Seether, Tragically Hip, Lynyrd Skynyrd, Styx and REO Speedwagon. Country acts, such as Keith Urban, Blake Shelton, Randy Travis and Alan Jackson. Comedians Jeff Dunham, Bill Engvall, Larry the Cable Guy and Jeff Foxworthy, just to name a few. The D.P.A.O. Concerts were the principal fundraising activity for the disabled children and adults in Jefferson and Lewis Counties.

The Disabled Persons Action Organization was created by Joe Rich, who at the time was an anchor for WWNY Radio and TV. Mr. Rich began the not for profit, part time in his home in 1974. The organization was fully incorporated as a non-profit in 1976. The mission was to provide quality and effective individualized services



for developmentally disabled children, adults and their families. Joe became the driving force behind the Summer Concert Series to provide the funds to support his endeavors to help the disabled.

The Fine Print Of A Red Scarf: Taylor Swift, Interpolation, And The Legal Loophole Of Genius

There's no easy way to talk about Taylor Swift without someone lighting a candle in her honor or lighting you on fire for even questioning her. She is an empire, an institution, and a lyrical surgeon. But even empires have fine print, and right now that fine print is spelled i-n-t-e-r-p-o-l-a-t-i-o-n.

If you just blinked at that word like a high schooler pretending to understand calculus, you are not alone. Interpolation is the lesser-known cousin of sampling. It happens when an artist re-records or re-creates a melody, lyric, or hook from an existing song rather than lifting the original recording. It is a creative homage when permission and payment are involved. When they are not, it is the musical equivalent of leaving your neighbor's house with their couch and claiming you just redecorated.

So when Ophelia dropped, somewhere around the thirty-second mark, my brain started screaming like a radio host with a red flag hotline. I had heard that melody before. It was not déjà vu, it was Summertime Sadness, Lana Del Rey's foggy, cinematic ghost drifting through Taylor's golden haze. I did what any self-respecting Swiftie and music nerd would do. I spiraled into a research hole and ended up on There I Ruined It, the Instagram account that hears what the rest of us cannot unhear. They had clocked it too, and a few other inspirations for good measure.

Before anyone comes for me with pitchforks and friendship bracelets, I am not here to crucify Taylor. I am here to talk about the system. Interpolation is not a new trick. It has been around since long before Auto-Tune and TikTok dance trends. The real question is when does homage cross into infringement, and why does it only seem to matter when it is the little guys doing it?

When a small indie band gets accused of borrowing a chord progression, they are slapped with a lawsuit that drains every cent they have ever made selling CDs out of their van.

Christine Collins When a superstar borrows from a smaller act, it is suddenly called influence, evolution, or shared creative language. It is a fascinating double standard wrapped in a glittered PR statement.

And the irony? Taylor knows better. On another track, Father Figure, she actually requested permission from George Michael's estate to use interpolation. That is a textbook, that is ethical, that is professional. The reason estates are so protective is simple. Dead artists cannot sue, but their intellectual property can still make money. When you get permission, everyone wins. When you do not, well, cue the lawyers.

So what happened here? In her promo interviews, Taylor said she reunited with Shellback and Max Martin, her old hit-making dream team, and that they had all learned new things. Cute sentiment. But if those new things sound suspiciously like Lana Del Rey's old things, we might have a conversation worth having. Especially when the songwriting credits list only Taylor, Max, and Shellback. None of the other names attached to the songs that appear to have inspired these melodies.

If you can get clearance for Father Figure, why not Ophelia? Was it an oversight, a gamble, or a quiet assumption that no one would call out the resemblance?

This is not about tearing down Taylor. It is about the blurry gray zone between inspiration and imitation. Fans deserve transparency. Artists deserve protection. And the industry desperately needs a reality check on who gets crucified and who gets canonized. Because if interpolation without consent becomes the norm, the creative middle class, the bands from Northern New York to Nashville, will pay the price long before billion-dollar pop factories ever feel the heat.

To understand how we got here, let's clear the smoke machine and talk about technicalities. Sampling is when you take a literal piece of the original recording, those exact vocals, that guitar lick, that beat, and drop it into your own track. It is borrowing sound. Interpolation is when you recreate that sound yourself. You do not take the recording, you just imitate it, same melody, different mic. Think of it as musical method acting. Both require permission. The only difference is what happens when you do not ask

In 1990. Vanilla Ice released Ice Ice Baby, which famously lifted the bassline from Under Pressure by Queen and David Bowie. His defense was that the bassline was slightly different. The world laughed, the lawyers did not, and a quiet settlement ensured that Queen and Bowie got their due. There is a difference between being inspired and being inspired to open your wallet.

Fast-forward to 2015. Blurred Lines by Robin Thicke and Pharrell was not a sample, it was an interpolation inspired by Marvin Gaye's Got to Give It Up. Thicke and Pharrell argued it was only a vibe, not a copy. The court disagreed. The Gaye estate walked away with five million dollars and a reminder that vibes can still cost you your vacation home.

Jump to Gen Z. In 2021, fans noticed Good 4 U by Olivia Rodrigo sounded eerily similar to Misery Business by Paramore. No lawsuits were filed, just an after-the-fact songwriting credit. A PR move? Probably. A lesson in modern copyright ethics? Absolutely.

Rodrigo handled it smartly, even if it meant retroactively slicing her roy-

Interpolation can be a love letter or a lawsuit. The only difference is the envelope it comes in, and whether the check clears before the lawyers get

So yes, I am still a Swiftie. I will still scream-sing All Too Well with a red scarf around my neck and too much Cabernet in my bloodstream. But as someone who has spent over two decades in this industry, I cannot ignore the hypocrisy. If we are going to live in a world where AI has to disclose its sources, maybe music should too.

Because maybe the real love story here is not between Taylor and her muses. It is between art and accountability.

into place that would be the downfall of a prominent fixture in the area. At one time, believe it or not, music wasn't free. The recording artists benefited financially from the sale of their releases. True, albums were taken over by cassettes and then CDs were in vogue, no matter what the channel, the sales brought forth millions of copies being sold. Several of the artists became very wealthy. Record companies prospered along with many in the music business. When Napster hit, which eventually turned into downloading and what we have today with streaming platforms, the revenue was cut drastically. The musician had to turn to a more extensive form of per-

years ago. Quite a few factors were put forming live. Expenses went up, ticket prices followed suite. The only way to make a living was to tour. Today we pay ten times more for a concert ticket. This affected cost for concert promoters like D.P.A.O. as well.

> In September of 2015 the Lakeview Amphitheater in Syracuse, NY opened for business. They had access to many of the artist being promoted by Live Nation, one of the largest promoters in the U.S. The artist under contract, would no longer be able to be booked for the D.P.A.O. shows. When Mike Campbell became Director of Operations, he worked diligently behind the scenes to rectify this situation. Hoping to expand



Michael Burpoe Featured At Adirondack Artists Guild

Michael Burpoe will be the featured artist at the Adirondack Artists Guild for the month of November with "HERE," a solo exhibition featuring 25 original watercolor paintings celebrating the culture of Saranac Lake.

Born and raised in Saranac Lake, Michael creates Adirondack culture paintings both en plein air and in-studio. He signs his work with his middle name, Czerny, a nod to the original spelling of his grandfather's name, which was changed when he immigrated from Poland. Michael studied Graphic Design at RIT's College of Imaging Arts and Sciences, graduating summa cum laude in 2017.

The Saranac Lake area is truly unique. The farther Michael travels, the more he realizes that what's found here cannot easily be found elsewhere. While many of his contemporaries and visiting artists focus on the stunning landscapes and world-class foliage, Michael is drawn to capture the people and culture that make this place one-of-a-kind. People who dance in the rain, paddle rivers before

the ice recedes, or dress up goat statues just to amuse passersby—these are the people of the North Country who inspire his work.

In May, Michael painted the newest mural in town at 60–62 Broadway, with the support of Jimmy and Johnny Williams and the help of friends and family. The mural depicts Adirondack legends Verplanck Colvin and Mills Blake surveying what would later become Saranac Lake. This project helped cement Michael's role in the local arts scene and contributed to him being awarded Best Artist in the Adirondack Daily Enterprise's 2025 Best of the Mountains.

Michael believes that the imperfections of a painting tell a story better than a photograph ever could. Each year, he partners with local groups and events to create illustrations that raise funds or awareness for beloved traditions. He has collaborated with the Lawn Chair Ladies, the Ice Palace Workers (IPW-101), and continues to celebrate community events such as Dewey Dubs, Party on the Patio, and

the Northern Current Music Festival—sometimes painting live, always dancing. Michael joined the Adirondack Artists Guild in January 2025, where he now maintains a rotating installation of his work. He hopes to bring youthful energy and fresh perspective to their lauded ranks.

"HERE" will be on exhibit from November 7th through December 1st, with an opening reception at the gallery on Friday, November 7th from 5 - 8 p.m. Beverages will be provided courtesy of Hex & Hops Brewing, with

appearances by some very special guests. All are welcome.

The Adirondack Artists Guild is a cooperative retail art gallery representing a diverse group of artists residing and working in the Tri-Lakes region of the Adirondack Park. The gallery is located at 52 Main St., Saranac Lake. Phone: (518) 891-2615. Gallery hours are Tuesday through Saturday 11 - 5 and Sundays 11 - 3. contacts within the music industry, Mr. Campbell traveled to Nashville to make arrangements with several music agents to bring talent to the North Country. We thought we were on the right path, but we needed to expand additional avenues to be profitable.

I personally saw the city of Watertown as a stumbling block. The ones in charge never seem to grasp the opportunity to pursue the D.P.A.O.'s ultimate goal. The end game being to help and support the disabled children and adults within the area. The decision makers were reluctant every step of the way. I feel the city and the county prospered with every concert. The sales tax revenue alone from concert attendees should have been an incentive to cut cost for the D.P.A.O. shows. People who travel out of the area spend money on hotel rooms, restaurants, gas stations and more. Additional revenue from parking would have cut the cost. Any other venue in the state charges four times what we had suggested. The city would not even consider this option for a nonprofit organization.

In 2024 Mike Campbell put together a committee of likeminded people in our community, who had experience within the music business. Our goal was to come up with suggestions that would allow D.P.A.O. to be more profitable. Mike Campbell, Robin Davis, Walt Young, Tricia Swartz, Mike Scriminger and I attended every meeting. Randy Pitkin, who has been in the entertainment business for decades, became part of the group in 2025. As

a committee, we came up with a new path consisting of many great ideas that we felt would accomplish our goals. For reasons unknown, not one of these suggestions was put in motion.

Unfortunately, there were other missed opportunities throughout the years that would have brought in musical acts that I personally feel would have been profitable, as well as some questionable decisions on acts that were booked.

All said and done, the D.P.A.O. had quite the run. The entertainment, on the most part, was very good. Procedures and operations before, throughout and at the end of the events were professionally handled with the musical artist, as well as the audience in mind. The safety concerns of all involved were first class. As far as I am concerned there should be a statue erected for Joe Rich. He brought us entertainment and enriched the lives of everyone around him, especially the disabled and their families.

I would like to thank all the people who allowed me to be the best I could be as a House Photographer – Especially Joe, Mike, Tracey and Mark.

Just to clarify – This article – The End of an Era was written from my viewpoint and perspective through my personal observations and concerns. It is not in any way the directive of this paper or D.P.A.O.




